

INTLAND SOFTWARE LICENSE AGREEMENT FOR RETINA SERVER AND CLIENT

Revised 27.07.2020

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE DOWNLOADING RETINA FROM THE INTLAND WEB SITE, OR INSTALLING THE PROGRAM ON YOUR COMPUTER. THIS LICENSE AGREEMENT ("AGREEMENT") IS A LEGAL AGREEMENT BETWEEN INTLAND SOFTWARE ("LICENSOR"), a GERMAN COMPANY AND THE INDIVIDUAL OR ENTITY ("LICENSEE") USING AND/OR ACCESSING THE RETINA SOFTWARE ("INTLAND PRODUCTS").

THE LICENSEE AGREES TO BE BOUND BY THE TERMS OF THIS LICENSE.

RETINA and the accompanying documentation are provided to the LICENSEE for use only under the following terms. LICENSOR reserves any right not expressly granted to the LICENSEE. The LICENSEE owns the downloaded product on which the Software is recorded, but LICENSOR retains ownership of all copies of the Software itself. The LICENSEE assumes sole responsibility for the installation, use and results obtained from use of the Software.

Definitions.

- a. **Server Software.** A "Server" means a physical or virtual machine capable of running server software. Each virtual machine is considered to be a separate Server. The Server Software consists of executable and non-executable application files that LICENSEE may download or receive on electronic media from INTLAND SOFTWARE.
- b. **Named License.** The Software works with user accounts. Each user account requires one Named License.
- c. **Floating License** is a license you can share in a network.

1. Software License.

This License Agreement grants LICENSEE the following non-exclusive rights:

a) RETINA Server. The LICENSEE may install and use one copy of the Server Software on one server computer. LICENSEE may make copies of the Server Software solely for backup purposes"

b) Type of Authorized Users. Users must consist of either (i) Licensee's employees, or (ii) representatives of Licensee's suppliers, vendors, customers or other business partners, provided that, and only as long as, such representatives are actively working on a Licensee project with a Licensee employee or are otherwise providing services to Licensee in direct support of Licensee's internal business operations.

c) Number of Users.

- (i) If you have acquired NAMED LICENSE, the Software may be accessed and used by up to that specified number of individual "Named Users" for whom Licensee has been purchased. LICENSEE may change the identity of the Named Users from time to time. The total number of RETINA user accounts may not exceed the total number of Named Licenses purchased.
- (ii) If you have acquired FLOATING LICENSE, the Software may be accessed and used by multiple concurrent users whereby the number of concurrent users at any point of time may not exceed the total number of Floating Licenses purchased.

2. **Restrictions Limitations on Reverse Engineering.**

The LICENSEE may NOT sublicense, assign, or distribute copies of the Software to others. The Software contains trade secrets.

a) Limitations on Reverse Engineering, Decompilation. The LICENSEE MAY NOT DECOMPILE, REVERSE ENGINEER or TRANSLATE the Software.

b) No copies or modifications. Except with respect to permitted modification, customization and distribution of the samples provided with the distribution kit, the Software may not be modified in any way.

c) No Rental. While LICENSEE may name non-employee third parties as authorized Named Users and/or Floating Users, this Agreement does not authorize LICENSEE to act as a RETINA Application Service Provider or commercial hoster, or otherwise allow LICENSEE to rent, lease or provide access to RETINA Software to third parties for their benefit.

d) No Transfer. Software may not be assigned or transferred without Intland prior consent.

3. **Protection and Security.**

The LICENSEE agrees to use its best efforts and to take all reasonable steps to safeguard the Software to ensure that no unauthorized person shall have access thereto and that no unauthorized copy, publication, disclosure or distribution in whole or in part, in any form, shall be made. The LICENSEE acknowledges that the Software contains valuable confidential information and trade secrets and that unauthorized use and/or copying is harmful to LICENSOR.

4. **Termination.**

This License is effective until terminated. This License will terminate immediately without notice from LICENSOR if the LICENSEE fails to comply with any of its provisions. Upon termination the LICENSEE must destroy the Software and all copies thereof, and the LICENSEE may terminate this License at any time by doing so.

5. **Limited Warranty.**

LICENSOR warrants that, from the date of initial use by the LICENSEE, the Software shall operate substantially in accordance with the published functional specifications current at the time of shipment. If, during the warranty period, a defect appears, LICENSEE shall return the Software to LICENSOR and LICENSOR's only obligation shall be, at LICENSOR's election, to replace the defective Software or refund the purchase price. The LICENSEE agrees that the foregoing constitutes the LICENSEE's sole and exclusive remedy for breach by LICENSOR under any warranties made under this Agreement. This warranty does not cover any Software that has been altered or changed in any way by the LICENSEE. LICENSOR is not responsible for problems associated with or caused by incompatible operating systems or equipment, or for problems in the interaction of the Software with software not furnished by LICENSOR.

No oral or written information or advice given by LICENSOR or its dealers, distributors, employees or agents shall in any way extend, modify or add to the foregoing warranty.

THE WARRANTY AND REMEDY PROVIDED ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE LICENSEE ASSUMES ALL RISK AS TO THE SUITABILITY, QUALITY, AND PERFORMANCE OF THE SOFTWARE. IN NO EVENT WILL LICENSOR, OR ITS DIRECTORS, OFFICERS, EMPLOYEES OR AFFILIATES, BE LIABLE TO THE LICENSEE FOR ANY CONSEQUENTIAL INCIDENTAL, INDIRECT, SPECIAL OR EXEMPLARY DAMAGES (INCLUDING DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF DATA OR BUSINESS INFORMATION, AND THE LIKE) ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE OR ACCOMPANYING WRITTEN MATERIALS, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

LICENSOR'S LIABILITY TO THE LICENSEE (IF ANY) FOR ACTUAL DIRECT DAMAGES FOR ANY CAUSE WHATSOEVER, AND REGARDLESS OF THE FORM OF THE ACTION, WILL BE LIMITED TO, AND IN NO EVENT SHALL EXCEED, THE AMOUNT ORIGINALLY PAID TO LICENSOR FOR THE LICENSE OF THE SOFTWARE.

IN NO EVENT SHALL LICENSOR'S OR ITS DIRECTORS, OFFICERS, EMPLOYEES OR AFFILIATES TOTAL CUMULATIVE LIABILITY TO ANY USER OR OTHER PARTY UNDER THESE TERMS OF SERVICE OR OTHERWISE EXCEED THE AMOUNT ORIGINALLY PAID TO LICENSOR FOR THE LICENSE OR SERVICE.

6. **Enhancements.**

From time to time LICENSOR may, in its sole discretion, advise the LICENSEE of updates, upgrades, enhancements or improvements to the Software and/or new releases of the Software (collectively, "Enhancements"), and may license the LICENSEE to use such Enhancements upon payment of prices as may be established by LICENSOR from time to time. If LICENSEE is covered through a valid Subscription and Support Agreement (annual fees are paid), then the Enhancements can be used at no additional cost. All such Enhancements to the Software provided to the LICENSEE shall also be governed by the terms of this License.

7. **General.**

This License will be governed by and construed in accordance with the laws of the Federal Republic of Germany, and shall insure to the benefit of LICENSOR and LICENSEE and their successors, assigns and legal representatives. If any provision of this License is held by a court of competent jurisdiction to be invalid or unenforceable to any extent under applicable law, that provision will be enforced to the maximum extent permissible and the remaining provisions of this License will remain in full force and effect. Any notices or other communications to be sent to LICENSOR must be mailed first class, postage prepaid, to Intland.

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof, and all prior proposals, agreements, representations, statements and undertakings are hereby expressly cancelled and superseded. This Agreement may not be changed or amended except by a written instrument executed by a duly authorized officer of LICENSOR.

8. **NOTICE.**

The Intland RETINA product is Copyrighted © by Intland GmbH. Intland RETINA and Intland are trademarks of Intland Software.

The Software is available for use by LICENSEE according to the License Agreement. Any reproduction or redistribution of the Software not in accordance with the License Agreement is expressly prohibited by law, and may result in severe civil and criminal penalties. Violators will be prosecuted to the maximum extent possible.

WITHOUT LIMITING THE FOREGOING, COPYING OR REPRODUCTION OF THE SOFTWARE TO ANY OTHER SERVER OR LOCATION FOR FURTHER REPRODUCTION OR REDISTRIBUTION IS EXPRESSLY PROHIBITED, UNLESS SUCH REPRODUCTION OR REDISTRIBUTION IS EXPRESSLY PERMITTED BY THE LICENSE AGREEMENT
